Bank Guarantee. The Contractor shall hold a valid irrevocable bank guarantee for the Contract in the form shown at Annex A, from a bank that shall be subject to acceptance by the Authority. The value of the guarantee shall be £375,000 (Three Hundred and Seventy Five Thousand pounds), but this value shall be subject to regular review.
